



HOMEOWNERS INSURANCE

What type of homeowners insurance do you have on your LOW home? It seems some LOW homeowners are erroneously covering their homes with condominium insurance which is incorrect and they are under insured. The homes in Lake of the Woods are not condominiums. They are conventional deeded private homes with lots and must be covered by the homeowner with Conventional Homeowners Insurance. The LOWHOA is not a condominium Association.

Condo vs. homeowners insurance: The difference between conventional and condo insurance concerns how much of your residence and property you have to insure. With a LOW home you are responsible for the inside and outside of your home, the land it sits on and possibly any damage caused to your neighbor's home and the Association's property. Conventional Homeowners Insurance should cover this.

Condo insurance on the other hand only covers the interior of your home from the studs inward and not the exterior of the home, the land or other damage costs. In the event of a fire for example, if you have condominium insurance, you will most likely have to pay out of pocket to rebuild your home along with other sundry damage. Your insurance company finding out you had condo insurance and not conventional coverage may also avoid any payment altogether. LOWHOA does not cover any home in Lake of the Woods with any insurance.

If you are not sure what homeowners insurance coverage you have, pull out your policy and read it over or contact your insurance agent to make sure you are properly covered. Insurance is only good when you need it!

MONEY MATTERS - Jo Elmblad

Though we haven't officially closed the books on 2015 yet we do have some final year-end adjustments to make, I thought you might appreciate a brief summary of our major operating expenses for the year. These totals are as of December 31, 2015: Payroll, retirement and medical benefits for our staff, \$234,516.88; Legal and Accounting Expense \$12,200.59; Clubhouse and Rec Supplies \$9,761.16; Pool Maintenance \$9,773.27; Lawn Maintenance \$121,185.70; Upgrade Landscaping \$63,061.70; Tree Maintenance \$59,600; Utilities (Refuse PU, Water, Electric & Phone) \$43,167.13; Supplies, Lumber, Paint, Gutters, Soffits& Siding \$68,997.96; Painting \$66,675.

Unadjusted reserve fund totals at year-end were Roof Fund, \$620,384.49; Capital Fund \$79,295.64 and R&R Fund \$253,520.07. Additionally, we have approximately \$250K in CDs in our operating fund plus an operating bank account total of \$208,509.16 as of December 31. Total fund balance for the Association at year end including operating and reserve funds was \$1,412,111.53.

Assessment Receivables totaled \$14,066.38 at year-end and we had Late Fee Receivables of \$1,000, Legal Receivables \$711.47, and Owner Interest Receivables of \$62.97 giving us an overall Receivables total of \$15,840.42.

Looking at our Expense/Income statements summarized as of year-end, we show actual expense of \$813,216.32 compared to budget of \$920,206 for a difference of \$106,989.58. We are fortunate to close out another year under budget. Again, we still need to make some end-of-year adjustments before all of the numbers are final.

LANDSCAPE NEWS

Attention Homeowners:

Now that we no longer have the newspaper recycle dumpster, it is important that you continue to re-cycle. Most owners have two re-cycle containers, one for newspapers, cardboard, paper boxes etc. and the other for glass, cans, plastic, etc. STYROFOAM (EGG CARTONS, PACKING NOODLES) ARE NEVER RECYCLED. You may take these items to Publix.

Please be a good neighbor and NEVER use recycle bins for trash. Use plastic bags or garbage cans (w/lids) for trash. This helps keep loose thrash from blowing around the complex and ending up in the landscaping.

If you don't have recycle bins, call Seminole County, 407-665-2260, and they will deliver to your home.

"These items ARE NOT included in the curbside recycling program:

Plastic bags, or cups, paper cups or paper plates (wax lined) motor oil or pesticide containers, light bulbs, aluminum foil or pie plates, paint or pesticide cans, electronic devices and egg cartons and styrofoam trays"

Question:

I have the square white manual exterior light fixtures and I would like to replace them with automatic ones. As I look around my street, I see different ones in use. Is there a fixture you could recommend?

Answer:

In order to maintain uniformity on the exterior of our homes, and before replacing or installing anything on the exterior you should always contact our office. Lake of the Woods HOA has regulations regarding these matters (ie: windows, doors, outside lights, antennas, satellite dishes, garage doors, skylights, etc.).

The <u>BUILDING & GROUNDS COMMITTEE</u> has recommended the following outside automatic security light fixture: Utilitech 26 watt Bronze CFL Dusk to Dawn Light (Item #458109, Model #FW26PCUT). The committee has made special arrangements with **LOWE'S**. The original price is \$39.98, but for Lake of the Woods residents it is only \$29.00. Please read the following directions for purchase:

- 1. Pay at commercial desk only.
- 2. Payment info is in the Lake of the Woods Commercial File.
