Thank you for the warm welcome and assistance you have provided to me during my first two months as your CAM. Our progress in repairing and beautifying our community would not have been possible without the kind cooperation of the committee chairs and members and the many neighbors who have shared their ideas and concerns. I look forward to building on these relationships as we move forward into 2021.

Below are just a few of the updates we have accomplished together over the past several months:

Building and Grounds

- Storm drainage pipe repairs have been completed.
- Erosion issues have been repaired at 138/140 Carolwood.
- Ten units (448-466 Meadowood) have been painted. We are entertaining proposals to complete six additional units (469-479)/
- We obtained proposals for sidewalk repairs in the maintenance area and Carolwood road/curb repair.
- Sliding doors in the auditorium have been repaired with new or adjusted rollers and functioning locks.
- Lighting fixtures on both sides of the auditorium have been replaced.

Landscaping

- New vegetation has been installed and irrigation repaired at 138/140 Carolwood.
- Holiday annuals were installed.
- Work has been approved and started to revegetate the fronts of 14 units
- North side irrigation pipes have been repaired and rerouted.
- We have streamlined and organized the landscape replacement process to facilitate a quicker and smoother process for residents and the landscaping team.

Operations

- We continue to work with our attorney to update the governing documents and address other pending items.
- We are continuing to streamline the invoicing process. All purchases will be approved by the CAM prior to their completion.
- Work orders are being keyed and tracked daily through Vantaca.
- We are staffed almost completely. Welcome to Alicia who joined our REC team.

Money Matters—Jo Elmblad

The Board approved our 2021 budget in November, including a 1.4% increase in our monthly assessment to \$215.16 (effective April 1, 2021). Please update your payment options to reflect that change for April 1. Also included is an increase of \$18,125 (4.5%) in 2021 Reserve Fund allocations totaling \$417,725. Our recent Reserve Study recommends increasing our reserve allocations over the next 5-6 years by an average of 13-14%. If we increase our assessment income amounts by 1-2% according to our CPI limitation, we

can't accommodate these suggested larger reserve allocations. Thus, we anticipate suggesting some modifications that will affect the final numbers, including changing estimated scheduled repairs/replacements or reevaluating expenses for particular scheduled activities, moving the expense to our operating budget, or possibly eliminating the activity.

At year-end 2020, we continue to be under budget for the year, due primarily to COVID-19's impact on community functions and activity. Our Assessments Receivable total as of November 30 was \$34,537.70, a very slight increase over last month at \$34,329,07. Our attorney continues to resolve four larger delinquent accounts (representing \$16,927 of our assessment receivables due); 2-3 more are likely to go in that same direction.

Revenue and Expense Statements showed Actual expense for the month of November at \$108,684.44 vs. Budget of \$112,153.56 and YTD Actual of \$1,127,285.30 vs. Budget of \$1,239,689.16. Our operating fund total at monthend was \$303,651.91. Reserve funds totaled \$2,957,631.02. You can view this information in detail plus past manager reports and Board minutes by accessing the Bono portal and selecting Docs/Financials (Homeowner View.)

Roof Repair expense YTD totals \$8,690 compared to our annual budgeted amount of \$5,000, putting us over budget for the year in that category. With a projected lifespan of 12-18 years for shingled roofs and 15-20 years for flat roofs, we need to closely attend to roof repair activity per our recent Reserve Study. Our roofs were last replaced in a five year phased approach in 2006-2010. Roof replacement and painting/building refurb are two of our largest reserve expenses.

Estimated reserve fund expenditures by year-end include \$50,400 for building refurb, \$21,500 for underground pipes, and \$5,000 for a golf cart.

At our December meeting, the Board did approve funding for ground/road repair, cart path repair from Truewood to maintenance shed, and adding electronic access system to the clubhouse. An ad hoc committee was appointed and approved to work on clubhouse restroom renovation.

The Pet Place—By Cari Sadler

Happy New Year! I hope this column finds you and your furry ones all doing well. As promised, the following is Part 2/2 to help you understand your pet's bloodwork. Have a great January!

CHEM panel (Blood Chemistries) These common blood serum tests evaluate organ function, electrolyte status, hormone levels and more and are important in evaluating older pets, pets with vomiting and diarrhea or toxin exposure, pets receiving long-term medications and overall health before anesthesia is used.

*ALB (albumin) is a serum protein that helps evaluate hydration, hemorrhage, and intestinal, liver, and kidney disease.

- *ALKP (alkaline phosphatase) elevations may indicate liver damage, Cushing's disease, and active bone growth in you pets. This test is especially important for cats.
- *ALT (alanine aminotransferase) is a sensitive indicator of active liver damage but doesn't indicate the cause.
- *AML (amylase) elevations show pancreatitis or kidney disease.
- *AST (aspartate aminotransferase) increases may indicate liver, heart, or skeletal muscle damage.
- *BUN (blood urea nitrogen) indicates kidney function. An increased blood level is called azotemia and can be caused by kidney, liver, heart disease, urethral obstruction, shock, and dehydration.
- *Ca (calcium) deviations can indicate a variety of disease. Tumors, hyperparathyroidism, kidney disease, and low albumin are just a few conditions that can alter serum calcium.
- *CHOL (cholesterol) is used to supplement the diagnosis of hypothyroidism, liver disease, Cushing's disease, and diabetes mellitus.
- *CI (chloride) is an electrolyte often lost with vomiting and Addison's disease. Elevations often indicate dehydration.
- *Cortisol is a hormone that is measured in tests for Cushing's (the low-dose dexamethasone suppression test) and Addison's disease (ACTH stimulation test).
- *CREA (creatinine) reveals kidney function. This test helps distinguish between kidney and non-kidney causes of elevate BUN.
- GGT (gamma glutamyl transferase) is an enzyme that indicates liver disease or corticosteroid excess.
- *GLOB (globulin) is a blood protein that often increases with chronic inflammation and certain disease states.
- *GLU (glucose) is a blood sugar. Elevated levels may indicate diabetes mellitus. Low levels can cause collapse, seizures or coma.
- *K (potassium) is an electrolyte lost with vomiting, diarrhea or excessive urination. Increased levels may indicate kidney failure, Addison's disease, dehydration, and urethral obstruction. High levels can lead to cardiac arrest.
- *LIP (lipase) is an enzyme that may indicate pancreatitis.
- *Na (sodium) is an electrolyte lost with vomiting, diarrhea, kidney disease, and Addison's disease. This test helps indicate hydration status.
- *PHOS (phosphorous) elevations are often associated with kidney disease, hyper-thyroidism, and bleeding disorders.
- *TBIL (total bilirubin) elevations may indicate liver or hemolytic disease. This test helps identify bile duct problems and certain
- *TP (total protein) indicates hydration status and provides additional information about the liver, kidneys, and infectious diseases.
- *T4 (thyroxine) is a thyroid hormone. Decrease levels often signal hypothyroidism in dogs, while high levels indicate hyperthyroidism in cats.

Tips and Tricks for Perfect Cakes! —Terry Brown

I was a professional cake decorator for many years, so I am pleased to share these tips and tricks for making perfect cakes to delight your friends and family,

- 1. You do not need to buy the Duncan Hines or Betty Crocker mixes. Instead, buy the cheapest mixes you can find, and add a tablespoon of mayonnaise to the mix to have a moist cake.
- Instead of adding water and oil to the mix according to the box instructions, substitute a can of pie filling and 2 eggs in the mixing bowl. Try some tasty combinations, like a chocolate cake mix and cherry pie filling. which was my mother's favorite. I prefer spice cake with apple pie filling (with cream cheese icing). White cake with cherry pie filling is also good combination, or substitute strawberry for cherry filling. Lemon pie filling combines well with a yellow or white cake for a special treat.
- To keep your cake from rising too much in the middle, pour your mixed cake around the outside edges of the cake pan. The edges will rise quicker than the middle. Do not pour directly into the middle. This trick is particularly helpful if you are stacking layers, so you don't have to cut off so much to get level stacks.
- Take your cakes to the next level by adding different extracts to the icing. Add peppermint extract to Christmas icings, for example, for a festive holiday taste.
- After removing your cake from the oven, cover it with a kitchen towel, and allow it to cool covered. Towel keeps the heat and steam in the cake.
