Although the committee has not yet made a formal recommendation, they have moved into the final stages of evaluating bids and options.

With large projects like Roofing moving forward and other exciting developments on the horizon, I have full confidence that we have the right board in place to keep Lake of the Woods a place we can be proud to call home. We sincerely appreciate your support, and look forward to seeing you at the next meeting!

### CAM CORNER/MANAGER'S REPORT

The annual meeting is behind us this year and the participation was outstanding. There were enough attendees to the meeting and ballots cast that there was a quorum for the Annual Meeting. A big thank you to all who participated in voting and thank you to those who put your name forward to serve the community as a Board Member.

Water Intrusion Update: The areas of water intrusion have been identified, the surveys have been completed, the engineer has drawn up the scope of work and the scope of work has been sent to various contractors who are qualified to complete the work. The engineer had a meeting with the contractors at the end of March where they walked the property going over the various steps of the project. The contractors are to have their proposals back to the engineer by mid-April. The contractors all put a duration of the project to complete at about 2 months. Progress is being made.......

**Re-roofing** Project Update: Roofing Consultants were contracted to write the scope of work for the re-roofing of Lake of the Woods. The scope has been written and was distributed to roofers. The roofing committee now has 4 bids, and they completed an initial review of the bids in late March. Once the roofing committee has completed their review they will make a recommendation to the Board of Directors. Progress is happening .......

### MONEY MATTERS

### JO ELMBLAD, FINANCE COMMITTEE CHAIRPERSON

- 1. New monthly assessment of \$245.36 effective April 1st
- 2. Balance Sheet: Operating account is \$508,429.68. Reserves is \$3,707,823.76 for a total of Fund balance of \$4,216,253.44
- 3. Late Fees have been re-installed. Our largest delinquent account is \$15,922.24. There is a total of 65 delinquent accounts as of the end of February.
- 4. Accounts Receivable at end of February is \$49,448.24
- 5. Monthly Expense: As of Feb. 2023, the actual expense is \$123,188.61 vs budget of \$133,177.32
- 6. Year to date expense: \$251,788.01 vs budget of \$266,354.64
- 7. CDs: our committee looked at interest rates at 3 different banks. Pacific Premier Bank has the best rate and participates in the CDARS network. Maturing CD's will be moved to Pacific Bank to give us a better return. Reserve account funds are at Schwab.
- 8. Line Item expenses over budget: (A) Irrigation repair \$6,025, budget of \$2,083.33. (B) Postage \$1,571.13 vs budget of \$208.33 (C) Copies and Printing \$1,733.33 vs \$250.00. These overages are partially due to the election of new Board members. (D) Clubhouse Expense \$8,130.52 vs budget \$1,416,67. This includes swing door \$1,710, parking lot and front lights \$3,184, pickle ball lines \$1,300, credit card purchase of \$1,454.61.
- 9. Access System: Monthly fee of \$119.68. Repair from Dec 2022 to Feb 2023 totaled \$7,227.88. Some of the expense was caused by the two hurricanes. We continue to work on secure access to the playground.
- 10. R&R Reserve expense: Ruth's Painting \$8,814, North Side pump \$9,000, Water Retention engineer retainer \$1,500.
- 11. Roof replacement estimates: range is \$6.1-\$6.3 million. Additional for plywood, fascia and gutter is additional and not yet known. Metal roof estimate is \$13.9 million.
- 12. Water intrusion repair plan is in progress, proposals expected in April-May. Watch for a meeting to be scheduled for the community.

Forbes ranked Pacific Premier the 9<sup>th</sup> Best Bank in America in 2023, and Truist only 93<sup>rd.</sup> That ranking is based on key indicators of banking health such as revenue provided to accounts per dollar invested by the bank, a low number of investments which do not return their value over time, and the ability to absorb financial losses in an economic downturn by choosing safe investment types. Investments made by Truist failed at nearly double the rate of investments made by Pacific Premier in 2023. We are confident Premier is a strong choice to weather these financial headwinds and keep our Association funds safe."





Time brings changes. One of those changes in LOW Landscape work is that the author of the last few land-scape columns, Fred Shoemaker, was elected to the Low Board of Directors. That would normally mean leaving the committee, but Fred was nominated as the ex-officio member of the Landscape Committee and accepted. So, you will still see him about looking for "green" things to do as well as new BOD duties.

One of those things is to test the irrigation clocks to determine what is connected to what. Apologies to anyone who got wet the weekend of March 12. What the records said was connected to Clocks 4, 5, and 6 was not correct.

Our findings so far are discouraging and will require some manual operation of the irrigation system during the day. Apologies in advance if you get wet while we save or green areas.

This year looks like it will bring a bumper crop of pests like thrips, aphids, and mites. While getting rid of these is the right plan, please "be bee friendly." Much of the pest problem can be solved with a short blast with a water hose. If more is needed, there are horticultural oils and soaps that work well while leaving the friendly critters like bees and ladybugs alone.

Volunteers make a difference. They certainly did at the event held by the Landscape Committee to replant the island on the north side. Here's a shot of them at the end of the event that included planting 125 irises and 7 hibiscus trees. ### **Building & Grounds Committee**

### Carol Wilks, Committee Chairperson

- 1. Iron Gates: 3 gate contractors have agreed to make the 4 approved gates. Get a copy of the gate designs at the office when you pick up the application for approval.
- 2. Wooden Gates: The design has been approved; Aronne Camilleri is the vendor. The gate will be made of Hardie Board, style and type of locks is at discretion of homeowner. Get a copy of the gate design at the office when you pick up the application for approval.
- 3. Garage Door: We have a garage door that is almost identical to the original. We will have pictures and descriptions at the next B&G Meeting in April. Everyone is invited to attend the meeting to see all items that have been approved.
- 4. Drainage System and Water Intrusion: Survey is completed, now Scope of Work is being written by one of the Engineers. When the Scope is ready, the Manager will submit it for bids. Both the Manager and the B&G Committee will make recommendations to the Board for approval.

REMEMBER IF YOU ADD ANYTHING TO THE OUTSIDE OF YOUR UNIT IT MUST BE APPROVED BY THE BUILDING AND GROUNDS COMMITTEE BEFORE IT CAN BE INSTALLED. THIS INCLUDES GATES, GARAGE DOORS, LIGHTS, SUN LIGHTS, WINDOWS, AND DOORS.

### TRASH AND RECYCLING PICK UP INFORMATION

- Regular trash will be picked up on Tuesdays and Fridays.
- Recycling is now picked up every Friday. You can contact Seminole County, 407-665-2260 to request recycle bins.
- Aluminum cans **ONLY** are picked up every Friday by the LOW Can-Can Committee. Be sure to separate your aluminum cans from other recycling if you wish to have them collected by the Can-can Committee.
- Yard trash is picked up on Wednesdays.

### **Bulk Item(s) Pick Up Information**

White goods and electronic waste must be scheduled in advance by calling 407-464-0664.

- Once pick up is scheduled for white goods/electronic waste, these item(s) may be placed on the 6 p.m. on Thursdays. Regular bulk items do not require advanced scheduling to be picked up.
- If the bulk item(s) is not picked up on Friday, the bulk item(s) must be removed from the curb and brought back inside until an alternative, scheduled pick up time can be made.

### **Bulk Item(s) Pick Up Information**

- Must be scheduled in advance by calling 407-464-0664.
- Once pick up is scheduled, the bulk item(s) may be placed on the curb after 6 p.m. the day prior to the scheduled pick up time.
- If the bulk item(s) is not picked up on the scheduled day, the bulk item(s) must be removed from the curb and brought back inside until an alternative, scheduled pick up time can be made.

No trash or bulk item(s) should be put out prior to 6 p.m. the day before pick up.



#### PARKING! DID YOU KNOW?

- Parking at the ends of streets is for guests only. Resident parking is available in the Clubhouse lot.
- Parking from 2AM -7AM requires a permit
- Speed limit is 15MPH
- At the end of your driveway is a flat curb called a "ribbon." The ribbon is not part of the driveway, and therefore, vehicles must be fully in the driveway and not over the ribbon.
- Trailers are prohibited in driveways, unless actively being loaded or unloaded. All unattached trailers must otherwise be parked at the rear of the Clubhouse lot, with a permit, if parking overnight.



# WHAT'S WRONG WITH THIS PICTURE? PARKING VIOLATION

The HOA is actively issuing violation notices. Parking into the street or parking outside of any perimeter of a driveway is a common and frequent violation. All vehicles and all parts of a vehicle (including bumper and trailer hitch) must be completely contained within a driveway. Many residents are unaware that driveways end at the 'ribbon.' The ribbon (some call it a 'flat curb') is actually part of

the street, <u>NOT</u> part of the driveway. In the photo above, the vehicle is about 15" past the property line - truck, bumper, and hitch are all extending over the 'ribbon' and into the street. **It's a violation!** 

Note: Owners are responsible to ensure their renter/tenants/guests comply with the Rules and Regulations. Renters/tenants are responsible to ensure their guests comply with the Rules and Regulations.

\*Pets are never permitted in the clubhouse, pool, playground, tennis courts, or fishing pier.


- All pets (dogs and cats) must be on a leash and attended to within the developed area of the property, per Seminole County Animal Services, Chapter 20 Ordinances Pertaining to Animals.
- No Owner, Resident, or Guest shall, either willfully or through a failure to exercise due care and control, permit any animal to defecate within Lake of the Woods, unless such person shall promptly remove and dispose of the excrement in a sanitary manner.
- All persons should be aware of and comply with Seminole County Animal Services, Chapter 20 Ordinances Pertaining to Animals, prohibiting animals running at large and causing a nuisance and other animal matters. A copy of this ordinance is available in the Association Manager's office for inspection.
- No Owner, Resident or Guest shall feed, offer food (except bird feeders) or leave food that may attract stray animals of any description.

### \* THESE RULES ARE NOT APPLICABLE TO SERVICE ANIMALS\*.

#### **SEMINOLE COUNTY ORDINANCE:**

### (Sec. 20.18. - Defecating.

- (a) *Private Property*. An animal owner shall promptly remove, and dispose of, in a sanitary manner, feces deposited by the animal on private property unless otherwise authorized by the property owner.
  - (b) *Public property*. An animal owner shall promptly remove, and dispose of, in a sanitary manner, feces deposited by the animal on public property, which includes but is not limited to, sidewalks, easements, and recreation areas.)
