#### Money Matters—Jo Elmblad

Our February 28, 2021 Balance Sheet shows our operating fund balance was \$416,448.69, and our Reserve fund total was \$2,880,638.62. Budget vs. Actual Expense comparison for our first two months of 2021 shows Actual expense of \$89,465.05 for February compared to Budget of \$114,792.53 for a difference of \$24,327.48. YTD results reflect Actual expense of \$212,575.10 vs. Budget of \$229,585.06 for a difference of \$17,009.96.

Our Accounts Receivable Aging report as of February 28 showed a Monthly Assessment Receivable total of \$28,042.39 compared to \$33,101.74 for January. The total of Aging Summary for January, which includes Receivables and numerous service fees and charges, was \$38,728.45. February's total was \$33,346.05 for comparison. The second quarter of the year begins April 1, and also effective that date, our monthly assessment changes to \$215.16. Don't forget to update your bill-paying procedure to reflect this new monthly amount. If you pay automatically through BB&T's ACH process, the adjustment is made for you.

And now a bit of historical info regarding our community and our monthly maintenance fees. Our community came into existence 46 years ago this month with the signing and filing of our documents with Seminole County on March 25, 1975. For that first year, the annual maintenance payment per unit was \$468 (\$39 per month.) Over the years, that maintenance amount has increased per our documents according to a comparison of September's CPI for our current year with the prior year's September CPI.

The largest increase thus far, using the CPI comparison, was a 4.94% increase in 2009. That amounted to \$8.40 and upped our monthly maintenance to \$178.90. There was no increase in 2016 due to the CPI comparison, and our maintenance figure remained at \$196.69. On two separate instances, however, the community voted for an increase larger than the CPI figure due to circumstances at the time. In 2001, we voted for an increase of \$13.23, which consisted of a combination of the CPI increase allowed plus \$10. In 2005, the community approved a Special Assessment of \$750 plus \$21.73 added to our monthly maintenance bringing the total to \$152.26.

Over the past 20 years, our annual increases have been less than 3% for 13 of those years, including the exceptions noted above and less than 2% for 11 of those years. As most of you know, our documents are being reviewed and likely revised soon. How we may adjust our maintenance fees is part of that review process. Stay tuned for more specifics about changes being considered over the coming months.


## The Mighty Oak Tree—By Ronda Christiansen and the Landscape Committee

How the earth has changed. Sixty million years ago, the earth was much warmer. The North Pole was heavily in ice, northern Canada was 20 degrees F warmer than today, and the southeast U.S. was tropical rainforest (Florida was under the Atlantic then). But there were no oak trees at all.

Oaks began to evolve in the north of the Americas and Europe. Fast forward today, there are over 400 species of oak trees. When they evolved, they mostly split into red and white oak varieties. Oaks were opportunists in their advance by adapting to the conditions of the area. Now they grow in very cold to hotter places in Mexico and beyond. Once established, oaks are major building material as well as a resource for artistic work. Testimony to its usefulness is the oak's history in shipbuilding. In particular, most of the warships at the time of the American Revolution until the age of iron hulls were made of live oak. A legacy of this is that the US Navy maintains a live oak plantation (Naval Support Activity Crane at Crane, Indiana) with 70-80 year old oaks to maintain the USS Constitution (Old Ironsides). As the oldest wooden warship still commissioned and afloat, its timbers need replacing periodically.

Live oaks can live hundreds of years (for example, the southern live oak at the Leu Garden entrance is about 320 years old by the "rule of 4" for live oak (4 years for every inch of diameter). Laurel oaks, which grow here at Lake of the Woods, live about 40 to 50 years. If you do the math, that puts a number of our laurels at the end of their days. Some of these have been identified already for removal as, in decline, they can be a safety hazard. They will soon be replaced either in kind or other trees to maintain our wooded canopy.



#### **FLEAS**

Let's face it; it's Florida. In Florida, you do not need a pet to get fleas in your home. Just open the front door. Fleas can be deadly to pets. They take blood meals off your pet and drain them of their blood, causing anemia and death if not treated. One ingested flea can also cause tapeworms, which may be seen in the stool or around the rectal area. Medication from the vet is required to treat this and any other parasite. One flea should be treated as a problem. The two options are: wait until you see a flea and then treat your pet and home accordingly or use prevention. The best and safest products on the market are Frontline, Advantage, Revolution, Comfortis, Capstar. These can kill fleas within 24 hours. They do not stop fleas from getting on your pet. What happens is the flea's nervous system is attacked, and they go into a paralyzing "frenzy," which causes them to die before they can bite or reproduce. Fleas have millions of nicotenal receptors; humans only have three making the products very safe for people to be around. \*Rule of Thumb: Grocery store/pet store flea products such as Hartz, BioSpot, Zodiac, all flea collars, and products containing pyrethrins should be avoided because they can result in serious toxic reactions and cannot be considered as safe as those obtained from your vet.

HEARTWORM PREVENTION Infected mosquitoes transmit heartworms. A mosquito bites an infected dog/cat, picks up the larvae, and then bites your animal- infecting your pet. Differing from dogs, it only takes one heartworm to kill a cat. Testing has not been perfected for cats and is therefore not done yearly as with dogs. Generally, veterinarians go by symptoms to decide if it is worth testing a cat for heartworms. Since the test only identifies one gender of the worm, it is possible to get a false-negative test result. However, if positive, it is definitely a positive result. Once heartworm symptoms are seen, the cat is usually in respiratory distress or has severe coughing (note, these symptoms can indicate several illness/infections). There is NO treatment for heartworm disease in cats. Prevention is the only safeguard. Heartworm prevention can be given monthly (same date monthly) by using Heartgard Plus and given as a treat (or you can use Revolution). Finicky cat? Hide Heartgard Plus in cheese, tuna wet food, or other really tasty favorite.
