**Re-Roofing Project**: 1<sup>st</sup> phase - Cam was directed to consult with different lenders to provide options so that the Board/Membership can decide how to proceed financially.

**Water intrusion:** Special BOD meeting was held 7/11/23 @7pm - Montje Plank with CFEC met with Board and Owners. Cam was directed to have the current bids broken down into sections and order additional surveys.

**Palm Tree Trimming:** Platinum Landscape has begun trimming palm trees. Started on Truewood Lane, making their way through each area as quickly as possible, weather permitting.

## Collection Policy for Lake of the Woods, HOA

Monthly Assessments are due on the 1st of every month.

1. Association assessment fees are due on the first of every month and must be received no later than the 10th of each month. If payment is not received within 10 days of the due date, a \$25 late fee, interest of 6% annum plus any collection fees will be charged and a notice of late assessment will be mailed to all known addresses on record.

2. If payment is not received within 40 days of due date, a 45- day Intent to Lien notice along with any collection charges for such notice shall be sent to owner. According to Florida Statute, letter should be sent both certified mail and regular mail to all known addresses at the time of processing.

3. If assessment is unpaid after the 45-day Intent to Lien Notice expires, the account shall be forwarded to the Attorney requesting the lien to be placed, and any further collection cost will be added to owner's account. The Board will review and execute the lien and Management will return it to the association's attorney. This is when the assessment is approximately 85 days past due.

4. Once the lien is recorded, a 45-day Intent to Foreclose letter is sent to the owner from the collections' Attorney.

5. If the owner does not pay prior to this 45-day expiration the manager will review the matter with the Board to determine if the Board wants to proceed with foreclosing on the property.

6. Board Policy is automatic approval for management to proceed with collections as outlined above, and lien foreclosure actions up to the actual filing of foreclosure.

Collection Policy Approved by the Board of Directors on 2-21-2023 at a Duly Noted Board Meeting.



## **MONEY MATTERS - Jo Elmblad**

**CPI & Assessment Update:** Per the U.S. Department of Labor's website, using the most recently published June 2023 index, the calculated amount of monthly increase we could have effective next April is \$6.56 Our actual figure will be determined after the September 2023 index is published and we're able to compare that to the September 2022 number. We normally won't see that number until mid October. Obviously, this isn't going to be enough to cover the expense of what needs to be done in our near future. Our contacts with Premier management, landscape company and irrigation repair are approaching their expiration date and are under current review. They are significant components of our 2024 budget.

For the past 4 years, we've had new management on board as we start the budget planning process. We've had staffing challenges as well as not having a full board of directors in place; We're short on committee chairs and members. We need your help! If you have the time and interest in maintaining our community, please consider joining a committee or volunteering for the Board or for committee chair positions.

**Financial reports, summarized through June 30, 2023** reflect the following: Budget vs. Actuals for June showed Actual expense of \$119,208.79 vs Budget of \$133,177.32 for a difference of \$13,968.53. YTD figures showed Actual expense of \$731,532.83 vs. Budget of \$799,063.92 for a difference of \$67,531.09.

Balance Sheet total assets as of June 30<sup>th</sup> were \$4,298,317.48. At the end of May, total assets were \$4,309,121.36.

Accounts Receivable total as of June 30<sup>th</sup> was \$46,168.05 compared to \$44,442.64 at the end of May. June's AR Aging report indicated 49 delinquent compared to 56 in May. Our largest delinquent account shows a total owed of \$17,130.26 at the end of June. Our actual delinquent **assessment** total was \$40,488.64. The difference between that total and the \$46,168.05 total is fees and charges to be paid to Premier.

Irrigation repair expense, continues to take a big bite of our budget. As of the end of June, our irrigation repair expense was \$2,442 for the month and \$29,464 YTD. Our initial 2023 **annua**l budget for irrigation repair was \$25,000. That was upped to \$35,000 by the Board at its April meeting. We're under budget for Maintenance Payroll (-\$12K) as of the end of June being short a position currently. It may be advantageous for us to go back to having a combination maintenance/irrigation employee to give us better oversight of our irrigation repair.

The plan to stop printing newsletter copies and rely on the online version was postponed to August in order to give everyone more time to adjust to the change. As explained in the June and July LOWHAN issues, you could request continuation of delivery of paper copies. Approximately 82 owners have asked for printed paper copies. Though it's encouraging to know residents are interested enough to make the request, the more we print, the bigger our expense.

Regarding our tree maintenance plans, palm tree booting is underway. Our tree maintenance annual budget is \$75K and YTD expense is \$12,080. If we're to trim trees for hurricane prep, we should be doing something soon.

Balance Sheet Reserve fund totals as of June 30, 2023 were Capital \$212,249.41; R&R \$796,899.80; and Roof \$2,857,716.89

The July 11 Special Board Meeting provided an overview of water intrusion problem areas in the community. It has also resulted in additional homes and areas being identified as problem areas. Flooding as a result of Ian or Nicole was not documented to the water intrusion engineer until more recently. Director Fred Shoemaker is working with the engineer to help develop a recovery plan. He is also becoming an irrigation technician of sorts, working to evaluate irrigation problems, invoices and proposals. And in his spare time, he's working improving our pool maintenance.

Information on roof replacement is still sketchy. At its July meeting, the Board approved approximately \$9K in roof repair expense. Also at that meeting a City National Florida banking rep reviewed guidelines and requirements for applying for a loan to cover a special assessment. Additional banking information is being obtained to help us select our best financing option.

- . Yard trash is picked up on Wednesdays. (Debris must be in a container or tied in a bundle.

#### **Bulk Item(s) Pick Up Information**

- Appliances and electronic waste must be scheduled in advance by calling 407-464-0664.
- Once pick up is scheduled for white goods/electronic waste, these item(s) may be placed on the curb after 6 p.m. on Thursdays. Regular bulk items do not require advanced scheduling to be picked up.
- If the bulk item(s) is not picked up on Friday, the bulk item(s) **must** be removed from the curb and brought back inside until an alternative, scheduled pick up time can be made.

No trash or bulk item(s) can be put out prior to 6p.m. the day before pick up.

#### SANDLESS SANDBAGS?

Following Hurricanes Ian and Nicole, research was conducted to identify an alternative to traditional sandbags to protect Lake of the Woods Townhomes from flood waters. Five sandless sandbags (dams) have been identified, but only three appear suitable to provide abatement of flood waters threatening residences: The three sandless sandbags are:

OUICK DAM: a self-activating patented gel barrier, tubelike height of 3-4", width 8", comes in various lengths, www.quickdams.com; QUICK DAM: 888-761-4405.

HYDRABARRIER: water fill barrier, tubelike height 3-4", width 8" comes in various lengths, www.hydrabarrier.com; WATERSHED INNOVATIONS: 888-876-4068.

PIG HOME SOLUTIONS: water fill barrier, tubelike; height 3-5", width 8", lengths vary, www.newpig.com, NEW PIG: 855-493-HOGS.

All prices vary with length from \$21.99 to \$100.00 and are available at/through Lowe's, Home Depot, COSTCO, ACE, and Amazon.

There are many reviews of successes and a few failures of these sandless sandbags on individual websites and on Amazon. While the use of these 'dams' appears better than traditional sandbags they may not always be successful as described in the various failures.



## **PARKING! DID YOU KNOW?**

- Parking at the ends of streets is for guests only. Resident parking is available in the Clubhouse lot.
- Parking from 2AM -7AM requires a permit. Go to LOW website: (www.lakeofthewoodshoa.com) to fill out form.
- Speed limit is 15MPH
- At the end of your driveway is a flat curb called a "ribbon." The ribbon is not part of the driveway, and therefore, • vehicles must be fully in the driveway and not over the ribbon.
- Trailers are prohibited in driveways, unless actively being loaded or unloaded. All unattached trailers must otherwise be parked at the rear of the Clubhouse lot, with a permit, if parking overnight.
