## MONEY MATTERS



Copies of our year-end Financial Statement as published by our accountant on April 16, were reviewed by the Finance Committee and copies may be obtained at the office if you'd like to take a personal look. The summary report confirms that our financial statements present fairly, the financial position of Lake of the Woods Homeowners Association, Inc. as of December 31, 2018, and that we conform to accounting principles generally accepted in the United States of America. According to the report, our total fund balance at year end was \$2,528,110.

Balance Sheet and Income Expense statements summarized through April 30, 2019 reflected a slight for Assessment Receivables, totaling \$37,887.47 compared to \$39,656.27 at the end of March. Late Fee Receivables totaled \$2,475; Legal Receivables were \$7,364.28; Owner Interest Receivables came to \$635.95.

Earlier this month, we received another sizable delinquent account payment which will continue to reduce our Assessment Receivables. The concern raised last month regarding when delinquent accounts are turned over to the attorney was resolved with Andra confirming that this would occur after two months of delinquency.

Looking at our operating budget results as of April 30th, our actual expense for the month of March was \$71,884.45 compared to budgeted expense \$93,070.73 for a difference of \$21,186.28. Significant under budget items for the month included Painting -\$6,250; Lumber -\$3,500; Lawn Maintenance -\$2,233.25; Accounting Fee -\$6,000; and Bank Charges -\$2,125.93. YTD results showed actual expense of \$316,345.14 vs. budget of \$367,025.05 for a difference of \$50,679.91. The open maintenance staff position continues to contribute to us being under budget (approximately \$12K) in maintenance salary as well as group medical insurance and FICA expense. Lumber, Replacement, Painting Expense, and Irrigation Repair are under budget YTD by -\$26,137.87.

Repair work of road/drain problems is still on hold

pending receipt of a third bid consistent with other bids received.

Evaluation of repair of a crack in our pool coping is in progress. We also anticipate unexpected additional expense to clear overgrowth and repairs falong the back of North Carolwood units as well as some other areas in the community that need attention.

#### MAY MANAGER'S REPORT

REMINDER - The new monthly assessment amount is \$208.68.

Our Maintenance crew is continuing repairs on North Carolwood and the painting will begin as repairs are completed. As each section is completed, the new landscape will be installed. Gutter company issues are being resolved so we can get back on track.

Trees will continue to be trimmed back and/or removed as much as possible before we enter the hurricane season. Work is also being done to clean up the back fence along the North side.

Please remember we are still on water restriction to 2X a week with the exception of new plantings. Brian continues with work orders on irrigation.

Please inspect your gutters before we hit the rainy season to prevent problems before they happen. HOA is only responsible for the courtyard gutters, the rest is up to you. If you need help with this task or have questions, please call the office.

if you want to plant anything in the flowerbed outside your courtyard, please submit an application to the Landscape Committee for approval. Send request to daniel@lakeofthewoodshoa.com or, there are forms in the office. Also be aware this is common property and if you do not maintain what you plant it will be either done so by the landscape crew and/or removed.


