As Chair of the Manager Search Committee I was fortunate to work with five extremely talented members of our community. I want to express a public "Thank You" to, Audrey Smith, Ann Gile, Elaine Noel, Mary Beth McAliley and Isabel Orr. who made the selection process a pleasure. I would also like to thank those residents who stepped up to help, wherever needed, during this transition period. All of us on the Board appreciate your efforts.

Additionally, during July, residents on the "North Side" of our community received an entire 3 days of intensive "clean up" with all trees being trimmed for hurricane protection and many dead trees removed. AND, it looks like the painting will be completed by end of September! Many streets in the community have had old and damaged drain pipes replaced and paved in preparation for painting of new traffic control signs. All the filters for the pool have been replaced and the pool filter tank and the entire pool house has been given a thorough cleaning.

# MONEY MATTERS

Balance Sheet and Income Expense statements summarized through July 31, 2019 showed our Assessments Receivables at \$30,269.21 compared to \$36,184.92 at the end of June. We received \$5,200 in July from our attorney from those delinquent owners committed to a payment plan. Late Fee, Legal, and Owner Interest Receivables for the month of July totaled \$6,157.64. However, with the transition in management and the "catching-up" of transactions and activity, those numbers may need adjusting.

Our operating budget results as of July 31st, showed actual expense for the month as \$102,042.13 compared to budgeted expense of \$79,155.84 for a difference of (\$22,886.29). YTD results showed actual expense of \$572,603.42 vs. budget of \$611,215.73 for a difference of \$38,612.31. Again, however, there are some correcting adjustments to be made which will change these results. We'll likely have less monthly expense in July, helping reduce that \$22,886.29 over budget figure. We continue to be under budget YTD in Maintenance Payroll (-\$11,772) due to being one person short in that area. Group Insurance-Medical (-\$8,515) is also affected by this as well as FICA expense (-\$3,822.) Painting (-\$8,000) and Irrigation expense (-\$7,305) also contribute to our being underbudget YTD.

A problem with our work comp coverage is being addressed as the result of receiving a bill for approximately \$8K due to prior policy term audit results. Apparently, some of the vendors/contractors we used last year could not be verified as having their own work comp coverage so their payroll was included in our payroll audit results. Gail Stanley, our new manager, will be working to resolve this problem.

We do have some significant invoices to pay for the northside cleanup, pool filter repair and road work. We'll have more detail on those expenses next month.

We've begun to look at our budget for 2020. It appears our allowed CPI increase will be in the \$3.50-\$4.00 range. Our Property/GL insurance expense is likely to increase by 15% according to our current agent. We'll also have other increases to factor in. Looking at our first draft version and essentially rolling our expense figures over for the coming year shows us being \$25.000 short when we compare income to anticipated expense for our operating budget. As you may remember, we are borrowing \$40,000 from prior years' budget surplus to balance our 2019 operating budget. Once we digest the reserve account expenses for this year, we'll take a serious look at what we should expect to accomplish next year and what we can afford to spend from Reserves.

As of the end of July, our operating fund balance was \$321,215.24. Reserve funds totaled \$2,355,243.61 bringing our total fund balance to \$2,676,458.85.
