## **Money Matters**

We're one month into this new year so far as our financial statements are concerned and well within our budget. Our fund balances at the end of January totaled \$2,489,701.60. I thought I'd give you a little more background as to how our annual operating budget is affected so far as our income is concerned. You already know that your monthly assessments are our primary source of income. 28% of that income goes to our reserve funds. The remaining 72% comprises our operating budget.

We do have some other sources of income though and that's what I'm detailing for you this month. Our auditorium or card room may be rented by residents or those from outside our community. The rental rate for the auditorium is 100 + state sales tax for residents or 250 + state sales tax for non-residents. The card room may be rented by residents for 25 or non-residents for 550. Deposits are required for either rental commitment. We do pay sales tax to the state on these rentals. For the year 2018, auditorium and card room rental contributed 4,450 of income to the Association. We also have advertising income to add to our total. That comes from selling ads in our monthly newsletter. A business card ad for the newsletter comes to 10 per month, or your can commit for a year's worth of business card ads for 100. A quarter page ad is 255;  $\frac{100}{2}$  page is 550; and you can run a full page ad for 575. Newsletter advertising income for 2018 was 360.

Another source of income is Estoppel fees. An estoppel fee is typically charged by a homeowner's association (HOA) to a title company for the HOA to check the status of the seller's account when a property within the association is being sold. By doing so, it's determined if the seller is behind on any payments that the buyer may be responsible for. Our Estoppel fee charge is \$250 per request. In 2018, we added \$10,925 to our income from Estoppel fees.

Late fees and interest charges also contribute income to our bottom line. A late fee of \$25 is charged if your assessment is not paid by the 10<sup>th</sup> of the month and you'll also pay a 6% interest charge. In 2018, we added \$7,614.77 to our income from late fees and interest. We also earn some interest income from funds deposited in our operating funds bank accounts. That amounted to \$79.33 in 2018.

Remember too that for this 2019 budget year, we are "borrowing" \$40,000 from our prior year budget surplus to balance our estimated operating expense.

All of this additional income goes into our general fund and is disbursed throughout the year according to our budget planning and authorization from the Board. If you are interested in learning more about what's happening in the community and what is planned, you're always welcome to attend monthly board and committee meetings.

#### MANAGER'S REPORT – February 2019

REMINDER – The Annual/Election meeting is March 5, 2019 at 7pm. If you are voting that night please come early to sign in and vote. The annual packets were sent out in January if you are missing any information please contact the office. The office has extra copies and will be happy to give you one.

Our new playground is now open. Let's work together to keep it nice and clean for everyone to enjoy. We now have shuffleboards and cornhole, items can be checked out from the recreation center.

The Landscape Committee is working on cleaning up the backs of the units. We are cutting the plants in back of the units down to the 5 feet. Lake of the Woods is a special type of community that allows homeowners to express their personalities with plantings. You have to fill out a request with the Landscape Committee but are still allowed some plants. Because of this the landscape company tries very hard to respect the homeowner signs stating "Do Not Trim". Other communities do not allow any personal items in the common areas for the reason the landscape companies are not custom landscape companies. We have a very large community and to single out certain homes, plants or trees makes it difficult for the company. This also pertains to the backs of the units where the homeowner has 18" from the building. Some areas the landscapers are not sure so they will not touch as instructed by the office. If you have something in the back of the unit that needs trimming contact the office and we will be happy to put a work order in for the trimming. Having the homeowners call the work order in helps eliminate upset homeowners. Mavericks crew onsite has done a great job trying to accommodate the homeowners and respect their wishes but sometimes accidents do happen. I ask that if you have a special plant please keep that item in your courtyard. Any questions contact the office.

Spring is coming... seems a little early but it's Florida. I would like to remind everyone to clean out their gutters in the front, back and sides of the home. If the courtyard gutters need cleaning contact the office to submit a work order.
