Holiday Party & Grand Re-opening

Over 80 people attended the combined annual holiday party and the clubhouse grand re-opening held on December 5. Thank you to the Social Sunshine Committee, the Board, and the office for its sponsorship, and to Ann Honbarrier and Paul Tambiano for providing the delightful music. Seeing so many neighbors celebrating the season together was the best part of making 2025 end in style!

The Special Assessment Payment is Due January 1

The special assessment of \$4,000 per home, which passed in November, is due January 1, 2026, and may be paid in full or in 12 equal installments calculated as noted in the schedule to the right. As always, you are welcome to pay ahead, but please do not pay behind, as the payments will then be considered in default of the 12-month payment plan and be subject to late fees (\$25.00) and interest (6%), which apply to the full amount owed at the time of default.

Roofing

The roofing project remains paused, with 12 buildings remaining to be re-roofed. The timeline for re-starting the project, which will be discussed at the January board meeting, will be based on projected special assessment collections to ensure sufficient funding is available to complete the project. Affected owners will be contacted directly once their building has been scheduled.

2026 Budget

The Board approved a provisional 2026 budget at the November 16 Board of Directors meeting. This year, the membership will vote on whether to fully fund the reserves, which would require a significant increase in the monthly assessment, or to fund them partially. Our governing documents permit the Association to increase assessments by the percentage determined annually by the Consumer Price Index (CPI); that is, the regular increase you have experienced each year. However, Florida Statute 720.303(6) requires capital reserves to be fully funded but permits associations to partially fund them by a vote of the membership.

Payment details: Payments are due on the 1st of each month and considered delinquent after the 10th. Late fees and interest are applied on the last day of the month.

The Association must pass a budget. The budget will be finalized at the January Board meeting, and two options will be presented for a membership vote:

- 1) Partial Reserve Funding – Per the Declaration in our documents, the monthly assessment can only be increased by the CPI (3% this year), which will only partially fund the reserves. A membership vote is required.
- 2) Full Reserve Funding – Per Florida Statutes 720.303(6), we are required to fully fund the reserves, but doing so exceeds the CPI. A membership vote is required to increase the amount above the CPI.

As with the special assessments for the roofing project, the Board is not authorized to make this decision for the Association without the membership's participation in voting.

As a reminder, the Association's budget is approved annually. Should the membership vote to partially fund the reserves for 2026, the membership will be asked to vote on this issue again for the 2027 budget.

PLEASE WATCH YOUR MAIL FOR THE 2026 BUDGET MAILING AND VOTING INFORMATION. Please vote when you receive these materials, regardless of your choice of action for 2026. Voting is your opportunity to have your voice counted in the operations and future of our community.

Detailed information will be included in the voting packet, hopefully answering any questions you may have. **However, if you have any questions, please contact the office or a Board member directly to obtain accurate answers and additional information. The Board members' email addresses are available on page 7 of the LWHAN.**

Fiber Optics is coming to the community.

By board vote at the November 18, 2025, duly called board meeting, GigaPower was approved to install fiber optic wiring in the community. This installation will provide you with additional internet and TV service options through AT&T now and other service providers in the future. **Switching to AT & T fiber is optional.** You can stay with your current provider if you choose, and that provider might offer you more competitive rates to compete with AT&T's presence in our community. The fiber-optics installation is scheduled for the first quarter of 2026. More information will be provided as soon as the timing is finalized.

Landscaping

The winter clean-up and trimming are in full progress. Foliage on backs and sides will be trimmed away from the buildings and lowered to 60" in general to ensure the good health of the plants. If you do not wish to have your plants trimmed, please post a sign in your area on the designated trimming morning and remove it at the end of the day. However, you will need to keep it trimmed away from the building and at a maximum height of 60" pending the type of landscape material installed.

Irrigation, Sod, and Jasmine.

Thank you for being patient as we continue to diagnose and repair pending and new irrigation challenges. Meanwhile, we are still reviewing and obtaining proposals for sod and Jasmine, starting with the first area behind the first three buildings on N Carolwood, the second area at Clock 6, and the third area at Meadowood from Wintergreen to Lake of the Woods Blvd. We will start this project as soon as these proposals are received and approved, and irrigation is operational.

Street/Asphalt Repairs

The City of Casselberry repaired a sewer pipe at the intersection of Meadowood and Wintergreen; now we are awaiting the asphalt repairs. We are also obtaining proposals for various other asphalt and storm drain repairs (Carolwood, Nettlewood, Woodridge, Drywood, Clubhouse parking lot) with completion anticipated by the end of Spring.

Large Maintenance Projects Completed & In Progress

The maintenance department has been working on several large projects in addition to the routine maintenance and work order requests. The perimeter wire fence has been repaired with only a few locations remaining; street markings are being repainted; and the electrical meter enclosures are being replaced. A great thank you to our dedicated maintenance staff for doing an outstanding job.

A warm welcome to our new Administrative Assistant, Lorna Rhagnanan. Please welcome her and introduce yourself next time you stop by the office.

MONEY MATTERS by Jo Elmblad

According to our November Balance Sheet, Reserve Fund balances at month-end were: Roof, \$17,282.97; R&R, \$404,892.77; Capital, \$240,945.19. The operating fund balance as of November 30 was \$358,317.22.

The monthly Operating Budget comparison for November shows Actual expense of \$137,894.27 vs. budget of \$139,569.20 for a difference of (\$1,624.93). The YTD comparison shows Actual of \$1,561,378.97 vs. budget of \$1,537,919.02 for a difference of (\$23,459.95.)

A few of our operating expenditures for the month included Legal Fees of \$13,844.44, the Pylewood well controller box for \$805, the replacement of four clubhouse shower valves for \$2,400, and \$5,800 for Tree Maintenance. Most of the tree maintenance expense was for tree removal, which will continue as our laurel oaks decline. Even more challenging is Seminole County's requirement to replace trees removed, in addition to our annual work to trim crepe myrtles and boot the palm trees. Our 2025 annual budget for tree maintenance is \$50,000, but our Actual expense through the end of November is \$113,585. Pool maintenance is also a challenging area. Although this year's Annual budget is \$18,270, the YTD actual expense is \$30,908.34. As we contemplate our Reserve funding, we must also seriously consider our operating budget. Increasing reserve allocations reduces the amount available for operating.

November's AR Aging report includes 55 delinquent owners with monthly assessment receivables totaling \$77,961.66. The \$6,500 Special Assessment collection continues with receivables totaling \$61,156.53 for 15 owners. Six owners are on payment plans.

Some owners have already paid the recently approved second special assessment of \$4,000, which is due January 1. The total amount of second special assessment funds deposited as of November 30 was \$76,000.

Several upcoming community voting events will soon be required regarding the full funding of reserves, the election of board members, and the acceptance of a required Capital Contribution for new buyers. Please watch your inboxes and mailboxes for more information, and consider attending board meetings or joining a committee to become more involved in our community's operations.

Parking Rules: Owners are responsible for ensuring their renters, tenants, and guests comply with LOW rules and regulations. Vehicles parked outside driveway perimeters are subject to towing. NOTE: Parking at the ends of streets is for guests only. Resident parking is available in the clubhouse lot. Violators are subject to towing without notice.

- A permit is required for parking from 2 a.m. to 7 a.m. Fill out the permit form on the LOW website (www.lakeofthewoodshoa.com).
- The speed limit is 15mph.
- The flat curb ribbon is not part of the driveway. Park vehicles fully in the driveway, not over the ribbon. Trailers are prohibited in driveways unless actively being loaded or unloaded.
- To obtain a parking pass for overnight guests, go to <https://www.lakeofthewoodshoa.com/parking-permit.php>. If your vehicle is towed, contact Constellation Towing at 407-831-3000 to arrange for its retrieval.

Trash & Recycling:

- Regular trash pickup: Tuesdays & Fridays. All waste placed outside for pickup must be contained in an enclosed container or garbage can. Do not place plastic bags or other loose waste at the curb.
- Recycling pickup is on Fridays. Contact Seminole County to request recycling bins at 407-665-2260.
- Please separate aluminum cans only and place them in a bag for pickup on Fridays.
- Yard trash is picked up on Wednesdays (debris must be in a container or tied in a bundle).
- **BULK ITEMS:** Schedule appliances and electronics in advance at 407-464-0664. Place them at the curb after 6 p.m. on Thursdays. Advance scheduling is not required for regular bulk items. If they are not picked up, do not leave them at the curb. No trash or bulk items can be put out before 6 p.m. on Thursday.
- **NON-RECYCLABLE ITEMS:** plastic bags/cups, wax-lined cups/plates, drinking glassware, Styrofoam trays, egg cartons, light bulbs, milk cartons, shredded paper, aluminum foil pie plates, paint/pesticide/motor oil containers, cardboard larger than 3'x3', electronic devices.
