#### Dear Owners & Residents:

Every day we are strategically engaged in expediting projects designed to improve the property. Below are updates on several major projects.

#### Water Intrusion Update:

Actions to date-----

The areas of water intrusion have been identified. The Board of Directors voted at the November meeting to move forward with the survey and have accepted a proposal from a survey company.

Next steps-----

After the survey is completed, an engineer will be chosen to write up the scope of work and recommend companies that can perform the work. Fortunately, Florida's drier months are nearly upon us, and we are working to have the project completed before the rainy season begins next year.

#### **Re-roofing Project:**

#### Actions to date-----

The Roofing Consultants who were hired to write the scope of work for the re-roofing of Lake of the Woods have completed the written scope and distributed it to prospective roofers.

We are awaiting bids which, unfortunately, have been slowed by Hurricane Ian and then Nicole

Next Steps-----

Once the bids have been received from the roofers, they will be submitted to the Board for selection.

The Holidays are a traditional time for families and friends to come together to celebrate, create memories and relax after a long year. The budget for 2023 was adopted at the last Board Meeting on 11-15-22.

The new assessment is effective April 1, 2023 and will be \$245.36 a month.

The approved budget is available to every owner upon written request.



#### 2023 US FLAG

#### **RETIREMENT EVENT**

#### On Saturday, January 7, 2023, from 10:00 a.m. to 11:30 a.m., the Lake of the Woods Community will host a 2023 US FLAG RETIREMENT EVENT in the parking lot in front of the LOW Clubhouse.

The purpose of the EVENT is to retire any US FLAG that is no longer a fitting emblem for display. Residents are encouraged to bring any US FLAG to the EVENT for retirement that is old, worn, frayed, faded, torn or tattered. The EVENT will provide an opportunity to show pride in our country and community.

If you are unable to attend, the US FLAG can be dropped off at Heather Campbell's residence, 100 Carolwood Blvd, or by calling for a pick-up, (407) 496-7005. A raffle of three US FLAGS will be held at the EVENT. The Seminole County Fire Department has committed to providing a Fire Department Unit for display. The Seminole County Sheriff's Office also has been issued an invitation to participate in this EVENT. Barring either department's diversion to an emergency call, the involvement of the fire and sheriffs personnel will provide an opportunity for children and adults to interact with them in non-emergency/official situations.



#### MONEY MATTERS—JO ELMBLAD

Our transition to a new management and accounting system continues to delay and impact our evaluation of history and current financial results as we work toward a reasonable comfort level. Our primary focus recently has been developing a budget for 2023. The Board, at its November meeting, approved the budget as presented. With that approval, as estimated previously, our monthly assessment will be \$245.36, effective April 1, 2023. This calculates to an increase of \$18.60 (8.2%).

The total assessment income for 2023 will be \$1,539,581. Of that total, we're allocating 33.8% (\$541,100) to our Reserves as recommended by our most recent Reserve Study. Those reserves will fund Roof replacement, water intrusion repair expense, and refurbishing of our buildings as well as a list of other community components needing repair or replacement. Irrigation repair expense has become a regular major expense,(\$38.6K as of September 30th). Our Reserve budget for 2023 will be dedicated to our most critical items mentioned above.

Our estimated assessment income for 2023 is not enough to cover our recommended reserve fund allocation and our estimated operating budget expense for 2023. Our *operating* budget includes standard and expected expenses such as utilities, insurance, management fees, routine maintenance, and salaries. Making an educated guess based on history and expected inflation, we have trimmed the expenses as much as we think reasonable. We also added estimated income from late fees, auditorium rental, interest, legal expense totaling approximately \$25K. That leaves us with a deficit of \$33,547 to balance. We are adding that amount as income from our prior years' budget surplus to make up the shortfall. Total 2023 budget for operating is \$1,598,128.

Our latest summary financial statements, as of September 30, represent the first month's paperwork from Premier Association Management. There are corrections and adjustments in process. Some budget vs. actual expense comparisons were not correct initially. A corrected comparison shows the month of September with Actual Expense of \$142,073.83 vs. Budget of \$120,025.76 for a difference of \$22,048.06. YTD figures are Actual Expense of \$1,012,406.17 vs. Budget of \$1,080,231.84 for a difference of \$67,825.47.

Accounts Receivable total for September increased to \$48,123.08 compared to \$30,492.26 in August. The change in banking and management is likely responsible for a large part of this as there has been confusion about how to successfully make monthly assessment payments. There are some other inconsistencies on the Balance Sheet regarding operating and reserve account transfers. At our August board meeting, the transfer of \$47,366.92 from a September maturing CD to our Roof Reserve fund was discussed and approved. The balance of the CD, approximately \$52,635.39, was to be put into a new CD. However, neither of those actions had occurred as of mid November. Lauretta has documented the specifics and corrections are in process. (Not having copies of board meeting minutes available for review by the community and committees makes it very difficult to keep track of action items and what's happening in the community.) Accounts Payable at the end of September totaled \$52,632.71 compared to \$4,486.63 for August.

Looking at our expense and transactions for the month of September, we are still learning what activities might be classified as additional duties subject to additional charges. One such notable charge was a \$300 expense for records request management. The invoice detail shows 4 hours of management time (\$75/hr) for records request. Certainly, we don't budget for this and need to find a better alternative. Additional billable tasks are part of our management contract, and we need to be more aware of what activities cost us additional management fees.

Unfortunately, we still don't have the roof replacement expense information yet, and that remains a major concern.

We'll be closing out the year soon but expect to have better and more efficient processes in place including an emphasis on better communication in 2023.



## Irrigation by the Numbers

One of the amenities of Lake of the Woods is the landscaping. Keeping up the greenery has been a challenge recently with the multiple (3+) changes of contractors, the changes of LOW management, and, of course, hurricane Ian.

The irrigation equipment that we all pay for owning and operating is divided up into North and South. The North side has two deep well pumps that have had their own issues in the last several years but are operating as designed now. The design of this system is relatively simple and serves the 94 units and the common areas on the north side.

The south side has had a tough time lately due to hurricane Ian. The pump system that is in the enclosure between the pool and the lake was completely submerged during Ian with the loss of major components in that system.

The damage has affected all the owners in Lake of the Woods in the amount of about \$70 per unit. The estimated repair cost total is around \$37,000 and includes estimated amounts of \$10,000 for new pump motors, another \$15,000 for controls and miscellaneous parts.

To put these numbers in context, the outside unit for our individual air conditioners might cost a couple of thousand dollars. But those units are constant speed (usually) and might consume 3000 watts. The two pumps in the south irrigation system are industrial duty and consume up to 15,000 watts each.

In addition, since the pumps serve ten irrigation zones on the south side for very different needs in terms of water pressure and flow, the system is programmed to provide exactly the pressure and flow to serve a very different spray and rotor delivery points on the system. To do this, the pump speed can be programmed to run from 350 rpm to 3500 rpm to meet the required flow and pressure. In addition, the pumps have "soft start and stop " included in the controls. This eliminates the shock to the 40+ year old irrigation system when the pumps start and stop.

But, you ask, how complicated can spraying water be? Here are the last numbers that hint at the complicated nature of the LOW southside irrigation system: there are ten zones with clocks. Connected to those clocks there are between five and 32 local zones with a combination of rotors and sprays serving varying needs from lawn to shrubs to flower beds. That makes for something in the range of 1000 variables that need controlling and maintenance, much of it with manual adjustment to individual rotors and sprays. Optimizing each variable in this system is quite a chore that Landscaping has been trying to accomplish through our irrigation contractor.

We will get there, but please be patient. This was not the only loss in hurricane Ian; there was much loss by individual owners. And, by rights, roofing and drainage are the priorities of the moment.

But some good news is that the pump system for the southside was repaired on 11/15 and is running again.

#### **VOLUNTEERS NEEDED**

A few years ago, Lake of the Woods had a group of volunteers who assisted residents with small tasks and repairs. That included activities like changing light bulbs, smoke alarm batteries, hanging pictures, light cleaning up of courtyard, etc. I want to bring this program back to life and am looking for volunteers willing to help. ## Happy Holidays from the Building & Grounds Committee

2022 has been quite the year! The Committee has reviewed approximately 40+ applications from homeowners requesting approval for projects to change or upgrade their properties. Happily many applications were approved.

The Committee also was tasked with examining the drainage-water intrusion issue and has been working hard to locate all areas that have experienced water intrusion into their homes. The list is long and has grown during the year. Although Hurricane IAN caused flooding, I did not receive any new water intrusion reports. we had water but I did not receive reports of new Water Intrusion location. However, after Nicole, ten additional units were reported from one building.

The Committee has made progress due in part to the initial assistance we received from an engineer who volunteered to write a scope of work for one unit. The repair was completed, and we are remaining vigilant to ensure water continues to drain away from the building on that site. Although this engineer was unavailable to evaluate and write a scope for the other sites around the community, the Board approved retaining a survey company to survey the water intrusion situation throughout the community. Then an engineer will be hired to write the scope of work that will allow this project to move forward. Our LCAM is assisting with the bidding process.

In 2023, the Committee will be updating the specifications for all the projects that homeowners need to reference when they desire to make exterior improvements to their homes. These items include: garage doors; exterior light fixtures; window replacements; room enclosures; screen porch upgrades; iron or wooden courtyard gate replacements; gutters and downspouts; TV antennas and satellite dishes; and driveway extensions or replacement. These updates will be very helpful to every owner.

Finally, I want to take this opportunity to thank our hardworking Committee members for their dedication to our property and homeowners, despite operating with fewer members this year. We would welcome new volunteers to Buildings and Grounds. Please, join us for a meeting, the first Tuesday of each month, at

7:00 p.m., and check us out. We have a lot to do, and we can use all the HELP we can get. I hope to see some new faces in January!

- If the bulk item(s) is not picked up on Friday, the bulk item(s) must be removed from the curb and brought back inside until an alternative, scheduled pick up time can be made.

No trash or bulk item(s) can be put out prior to 6p.m. the day before pick up.


