PRESIDENT'S MESSAGE

Dear Neighbors-

October was quite a month.

Hurricane Ian was a significant event for our community; many residents experienced a considerable impact, heartache, and even loss. Please know you are in our thoughts and hopes throughout the recovery process.

While we are individually dealing with our recoveries, the greater community also experienced some flooding and damage. Our landscaping vendor was on standby throughout the storm and sprang into action, beginning the cleanup process less than 48 hours after the storm began. I've heard many positive comments commending their excellent job restoring some sense of normalcy. We greatly appreciate their flexibility and hard work!

We are still working on restoring a handful of other damages from Hurricane Ian, including major damage to our irrigation system. While we are pushing for repairs, please know that we're also exploring grants and subsidies to help offset the associated costs.

Hurricane Ian also cast a new urgency on our existing projects, including roofing and water intrusion. While the project costs have become prohibitive in the short term, be assured we have not lost sight of them and are still working diligently to resolve them.

Separately, the HOA Board was served with a recall notice concerning Director Terri Straub on Saturday, October 15. The papers served included 308 recall ballots; 20 voted to retain Ms. Straub, 287 voted to recall her, and one abstained from voting. After some review, the board could not verify three of the ballots voting to recall, so the final count in the recall effort was 20 votes to retain and 284 to recall. As a result, the board met Monday, October 17, to certify the recall, and Ms. Straub was removed from the board. We appreciate her past service and input.

There are now three open seats on the Board of Directors. Elections are coming up in March, and we are optimistic that we can fill these vacancies with community-minded, rational people with a passion for helping others. If you would like to contribute to your community by serving on the board, I strongly encourage you to get as active as possible. Join committees, come to social events, and—above all, since this is what we're here to do—help your neighbors. The nomination process and timing will be announced in an upcoming LOWHAN.

Our next Board meeting is November 15; this is a great opportunity to be involved and contribute. We hope to see you there!

CAM CORNER/MANAGER'S REPORT

Dear Owners & Residents:

- November 8, 2022 – Election at the Clubhouse

Premier Association Management has been on-site at Lake of the Woods HOA now for 2 months. Thank you for inviting us to manage your community!

We have been working to make the transition as smooth as possible, and we appreciate the folks who have stopped by the office to introduce themselves and to give us a warm welcome. We learned very quickly that Lake of the Woods is a wonderful, close community with a rich history here in Fern Park.

Two areas of concern surfaced from the beginning, and we assure you they are always a top priority:

1. Re-roofing of the units: The roofing consulting company has received the bids, which they will be providing to the community this week.
2. Water drainage and intrusion: We are in the process of scheduling with a company to survey the areas with the water drainage issues. Once we have the survey, we will be able to have some plans drawn up on how to help the water drain properly.

We survived Hurricane Ian but had damage to the Hoover Irrigation Pump (set behind the pool area), which will need to be rebuilt. This means there will be no irrigation on the South side until the pump is repaired.

I want to give a shout-out to the Landscape company, Platinum, for their speedy post-hurricane cleanup of the community.

I want to take this opportunity to thank the maintenance and rec staff and our new admin, Michelle, for their hard work to keep the community running efficiently every day. We appreciate each of you for your hard work, energy, and expertise to make this a great community in which to work and live. Happy Thanksgiving!

IMPORTANT—NOVEMBER 8TH ELECTION

This is a reminder that the Lake of the Woods Clubhouse is a polling location on voting day. We are anticipating a large turnout of voters in our area. We are asking everyone to please be aware there will be heavy flow of traffic coming to the clubhouse; however, the area will be manned by a parking crew to help with the flow of traffic and volunteers who will help direct voters to the proper place. Thank you in advance for your cooperation and consideration.



MONEY MATTERS—JO ELMBLAD

Looking back over the past three years of “Money Matters” articles published in November, the commentary is quite similar. We are struggling to balance the budget for the coming year, we have new management and a new accounting system, and we need to put more money into our Reserve funds. We have upped the Reserve fund contributions to 33.8% (\$521,100) of our assessment income for 2023 compared to (29.6%) \$399,600 in 2020, a 30% increase. By increasing our contribution to Reserves, however, we are also reducing the amount of our operating budget.

Our 2020-2021 Reserve Study lists 49 General Reserve Components and two Roof Reserve Components with current and future local costs of replacement, 0.9% anticipated annual rate of return on invested reserves, and 2.0% inflation rate for estimating Future Replacement Costs. For 2022, the Study suggested we refurb 45 units (\$117,045); repair chain link fencing (\$12,485); update 4 irrigation controllers (\$18,727); replace a golf cart (\$5,202); and have another Reserve Study (\$5,900.) How many activities were completed? Certainly, not all. Yet, we have faced several reserve expenses that were not anticipated in the Reserve Study schedule. At the October Board meeting, the Board approved spending not more than \$50,000 to repair our Hoover pump system which was flooded by Ian’s rains. It is an unplanned but certainly necessary repair.

Roof replacement, water intrusion repair expense, and building refurbishments significantly impact our reserve funds. Our water intrusion problem is not specifically listed as a component in our Reserve study, but its expense will be covered by our Reserve Funds. (After Ian’s visit, we currently have 50 units with water intrusion concerns.) Because these three areas are such significant and expensive projects, they will likely deplete our Reserves or come close to it. That leaves us with 40+ components that are lesser priority but will still need attention at some point. We need to be thinking now and planning how we can maximize the outcomes and what financial alternatives are available to increase our Reserve funding while maintaining an adequate operating budget.

Our 2023 budget is under development. Our assessment increase in 2023 calculates to a monthly assessment of \$245.36 according to the September 2021-2022 CPI comparison and would be effective April 1, 2023, pending Board approval. This is an increase of \$18.60(8.2%.) per month. Our current budget draft version shows us already over budget by \$27,612, with salary, insurance expense, and other adjustments still to be firmed, putting us in a deeper hole. Salaries so far total \$391,700 (25% of our assessment income.) Estimated increase in our property/liability insurance expense is 20-30%. (\$47K vs. \$56K.) Total estimated assessment income for 2023 is \$1,527,038.

Between management changes, Ian’s destructive visit, system outages, and corrupted files, the September summary financial reports have been delayed. This first-ever occurrence is particularly limiting as we attempt to assemble an annual budget that is typically presented and approved at our November board meeting. Thus, the delayed delivery of summary financial reports from Premiere is a concern relative to the timing of our Board, Finance, and Audit Committee meetings as we approach the scheduled November and December meetings.

The long-awaited proposals for our roof replacement effort were due on October 18, so we should soon know our options to plan and engage in that effort.

Clearly, the finances for next year will be extremely challenging and will require a really cooperative effort from the community to get through the year successfully. WE welcome your help. Please consider serving on a committee or running for the Board.

Event Accomplishments

Together, we planted 1,152 native plants (700 duck potato, 200 iris, 150 pickerelweed, 100 crinum lily, and 2 cypress trees). We also removed 42 bags of invasive torpedo grass and alligatorweed (6.3 cubic yards) and 2 bags of trash (0.3 cubic yards). Wow! Your hard work has helped to improve water quality and habitat for wildlife.





NEWS FROM BUILDING & GROUNDS!

The Buildings & Grounds Committee has worked all year to develop a plan to repair the areas on the property that have experienced water intrusion. Although the Board has been reticent to begin this large project due to the hefty costs and limited availability of funding, the Committee eventually was tasked to begin working on this issue to help those homeowners who were experiencing this situation.

Since then, the B & G Committee has been very productive.

We walked the property and studied the grounds. During this examination, we were fortunate to meet an engineer who was working to fix an intrusion for a homeowner located on the north side of LOW. This person met with the homeowner, members of the B&G Committee, and me at the property and provided an excellent presentation and Scope of Work. The engineer explained how the repair would work. I felt we were on the right path.

The Committee worked with the LCAM to disseminate the Scope of Work and obtain bids from four different Contractors. Each committee member had a copy of the bids, evaluated them, and individually identified the contractor they thought would work best for us. The chosen contractor was awarded the job and completed it in a timely manner. We have continued to monitor the work and are particularly impressed that the repair was not impacted by hurricane Ian.

Several other units on lower portions of the street did not fare as well, due to the flooding caused by the heavy rain and street drains that were overwhelmed by water, leaves, and debris. One building had water in all ten units.

Water intrusion is profoundly serious. At this time, our new LCAM is seeking out additional engineers for Scope of Work, and hopeful we will be on track to move forward. The B & G Committee and I will be working to speed up the process and get going, pending the Board's blessings. Please know that we are all concerned and working on this issue. Be assured that there is a light at the end of the tunnel.

TRASH AND RECYCLING PICK UP INFORMATION

- Regular trash will be picked up on Tuesdays and Fridays.

- White goods and electronic waste must be scheduled in advance by calling 407-464-0664.
- Once pick up is scheduled for white goods/electronic waste, these item(s) may be placed on the curb after 6 p.m. on Thursdays. Regular bulk items do not require advanced scheduling to be picked up.
- If the bulk item(s) is not picked up on Friday, the bulk item(s) must be removed from the curb and brought back inside until an alternative, scheduled pick up time can be made.

No trash or bulk item(s) can be put out prior to 6p.m. the day before pick up.

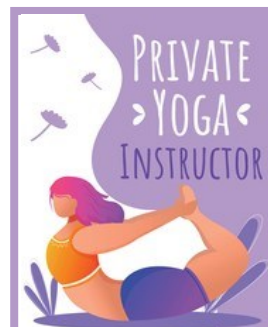

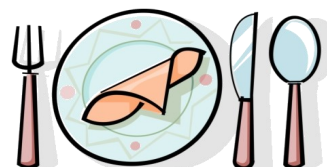

DONATE TO ENGLISH ESTATES ELEMENTARY SCHOOL

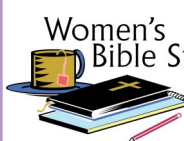

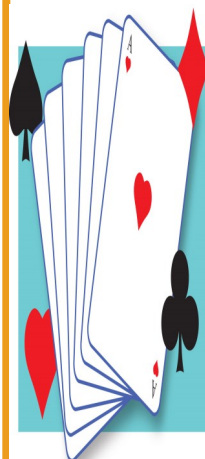
